OFFICE OF MANAGEMENT AND BUDGET Final Information Quality Bulletin for Peer Review INTRODUCTION This Bulletin establishes that important scientific information shall be peer reviewed by qualified specialists before it is disseminated by the federal government. We published a proposed Bulletin on September 15, 2003.

OMB Memorandum M-19-15 requires agencies to maximize the quality, objectivity, utility, and integrity of information disseminated to the public, and define mechanisms for redress by affected parties, where appropriate. In response, SLOs & HoCs will use this guidance to: Pre-Dissemination Practices.

Information Quality

The report should include the following: (1) The number of peer reviews conducted subject to the Bulletin (i.e., for influential scientific information and highly influential scientific assessments); (2) the number of times alternative procedures were invoked; (3) the number of times waivers or deferrals were invoked (and in the case of deferrals, the length of time elapsed between the deferral and the peer review); (4) any decision to

appoint a reviewer pursuant to any exception to the ...

Final Information Quality Bulletin for Peer Review

OMB review considerations include underlying statutory, regulatory, budgetary, privacy and policy issues and information quality, statistical design and methodology concerns. OMB pays particular attention to the practical utility of the data to the federal government.

Pre-Dissemination Review and Peer Review of Influential Scientific Information: The OMB Guidelines characterize a subset of agency information as “influential” scientific information, and apply stricter quality standards to the dissemination of information that is considered influential. Specifically, if an agency is responsible for disseminating influential scientific, financial, or statistical information, agency guidelines shall include a high degree of transparency about data and ...

By exempting RIAs, OMB is removing the requirement for peer review from the area where it is least likely to have beneficial effects. While the revised guidelines better tailor peer review as

a positive influence on the regulatory process, I continue to have some concerns. These concerns, which are detailed below, fall into three categories.

Most comments approved of the prominent role that peer review plays in the OMB guidelines. Some comments contended that peer review was not accepted as a universal standard that incorporates an established, practiced, and sufficient level of objectivity.

Conduct a peer review that meets the standards recommended by the OMB Bulletin. Where appropriate, subject the information to formal, independent, external peer review to ensure its objectivity. If data and analytic results have been subjected to such a review, the information may generally be presumed to be of acceptable objectivity.
